

# Board Meeting Minutes March 18, 2020

### I) Call to Order

### II) Items for Approval

- a) Consent Agendas
  - Baumhaus agreement (HBBC)

**Resolved:** That the Board of Directors hereby ratifies the Community Agreement reached with Baumhaus II and the residents of Centre Court Villa and authorizes the President to sign the said Community Agreement on behalf of the FCG.

ii) Audit Committee members (EC)

**Resolved:** That Tom Youngs (chair), Evan Tobin and Evan Stein are designated as an Audit Committee to review the Fiscal Year 2019 Friendship Community Group financial records.

iii) Corporate address for the State (EC)

Whereas the current registered office of the Friendship Community Group is that of the past president of FCG and therefore needs to be changed, and

Whereas, the Bloomfield Garfield Corporation has agreed to the use of their address as the registered office of the Friendship Community Group,

**Therefore, be it resolved that** the Secretary is authorized and directed to change the registered office of the Friendship Community Group at the Pennsylvania Department of State to 5149 Penn Avenue, Pittsburgh PA 15224

**Resolved:** That the resolution of the February 2020 Board of Directors meeting notwithstanding, the board approves the recommendation of The Pittsburgh Foundation that the Friendship Playground fund be designated to support the Friendship Community Group to be used solely and exclusively for the Friendship Play Park at the Montessori School.
